6. Shipton Court wall

Following the collapse of part of the wall on A361, the PC has been in contact with OCC, WODC, Strutt and Parker and the chairman of the Shipton Court Resident's Association to try to speed up clearance and the re-opening of the main road.

Many complaints have been received from residents, especially those on Plum Lane as the designated diversion was unsuitable. The verges have been left in a terrible state from vehicles including HGVs, accessing a lane for which they are not suitable. This has been reported to OCC who has responsibility for verges.

A suggestion that a pedestrian route through the grounds of Shipton Court is marked out, is currently being investigated. An email has been received from the chairman of the Management Committee of Shipton Court, explaining what needs to be done if this were to be possible. The clerk will:

- contact Oxfordshire County Council to discover how it intends to proceed with restoration of the verges
- contact Strutt Parker to find out its intentions regarding the wall
- contact English Heritage in February
- inform the village of progress via the Shipton Alerts system
