7.1 Applications received from WODC

24/01566/FUL Land Adjacent To 10 Coombes Close Shipton Under Wychwood Erection of a detached dwelling with off street parking and associated works.

7.2 Under consideration

24/01418/LBC Summerhouse Shipton Court High Street Internal and external alterations to include installation of new windows and dormers, changes to internal layout and construction of new entrance gates and stone pillars. Parish Council had no objection, subject to clarification of the biodiversity form, which had some discrepancies.

24/01500/HHD New Barn Cottages, Swinbrook Road, Shipton Under Wychwood Erection of a first floor extension to front elevation Parish Council has no objection, especially as the immediate neighbours are happy with the plans.

24/01126/LBC The New House, Ascott Road, Shipton under Wychwood Internal and external works including, refurbish windows including replacement of single glazing with double glazing, install bathroom extractor fans and roof vents, kitchen extractor fans and a wall vent., alterations to external store, and replace flat roof covering and fascia boards. Parish Council has no objection.

24/01260/LBC Shipton Lodge, High Street, Shipton under Wychwood Internal alterations to create accessible shower room and pantry, including removal of modern internal partitions and associated fixtures, erection of stud partitions, formation of 2 internal openings and associated works. Parish Council has no objection and commented that the design works hard to preserve the integrity of the house.

24/01384/FUL Cricket Ground High Street Shipton Under Wychwood Erection of a clubhouse, storage and scorer's hut. Parish Council has no objection, subject to there being more than one b

Parish Council has no objection, subject to there being more than one bat box installed. They also suggested that the kitchen and bar be connected.

24/01062/S73 Wychwood Inn, High Street, Shipton under Wychwood Variation of condition 4 of planning permission 24/00200/FUL Parish Council has no objection.

24/00949/FUL Land North East Of Simons Croft, Upper End, Shipton Under Wychwood Change of use of part site to residential garden, replacement of stables with home office and associated landscape proposals.

Parish Council initially objected to this application but, following provision of futher information and an invitation to resubmit, posted a no objection comment.

22/00612/FUL The Old Prebendal House, Station Road, Shipton under Wychwood Flood mitigation works together with landscaping and associated works. Parish Council objected, on the grounds of increased flood risk to the surrounding properties.

24/01103/LBC Shipton Lodge Cottage, High Street, Shipton Under Wychwood Internal alterations to Install a through floor lift. Parish Council has no objection. Approved by WODC 17th June 2024.

24/00954/HHD Cotswold, 7 Plum Lane, Shipton Under Wychwood Demolition of garden shed and greenhouse and erection of a workshop for hobby purposes. Parish Council has no objection, but suggested that the roof edge be moved further aaway from the neighbouring wall. Approved by WODC 24th June 2024.
